

NON MEMBER MANUFACTURER SYSTEM EXCLUSIVE ID APPLICATION

The MIDI Manufacturers Association issues System Exclusive ID numbers to MIDI manufacturers worldwide, except for Japan. These ID numbers allow manufacturers to uniquely identify their products while providing a means for communicating product-specific data via MIDI.

The MMA procedures for the assignment of System Exclusive ID numbers are designed to prevent conflicts and incompatibilities. Each manufacturer is assigned a unique number, which will be annually renewable. These numbers are not transferable, nor assignable by any other person or organization. A manufacturer may only receive one ID number.

The MIDI 1.0 Detailed specification describes all of the System Exclusive messages, as well as all other MIDI messages that a manufacturer may need to know to maintain industry compatibility. Technical assistance is available to MMA members via an assigned Tech Board representative.

The MMA maintains a database of every assigned and unassigned System Exclusive ID number. Companies that are known to be producing products using their ID may be listed on the MMA web site (www.midi.org) along with a link to their company web site.
